## **Officer's Reports**

Ken Lovell – Acting President:

Ken Lovell – Vice President:

- still outstanding discipline issues remaining open. Still open largely due to lack of responsiveness by Clubs in question. It is not the leagues responsibility to actively seek closure when no contact is made by Club.

John Corbett – Referee Organization:

 Discussion of confusion over game length & compensation for the U15 vs U15/16 age groups. May be considered as an AGM topic (redefining game length) but no changes to be made this year due to impact on fees & rules. Sue to verify state-level approach. Clarification will be shared with refs.

Bruce Lane – Registrar/Respect Campaign:

- Summary page of sportsmanship report will be posted to the website. No further statistical analysis will be done.
- Need to continue to assess the future approach for the Respect Campaign process to increase its effectiveness.
- Referee assessments will go to John Corbett

- John Corbett will continue to work with referee to ensure timely/accurate submission of game sheets (and sportsmanship scores)
- Poor scores will still be investigated by the league with teams in question.

Administrator Report – Sue Crabtree

- Provided league participation status report
- Fielded a question from Reeths Puffer regarding early card request payment vs. non-receipt of cards (resolution pursued separate from meeting)

## New Business

- Installation of Interim Board Members Clarified process for installing interim board members (president specifically) as specified in by-laws. At this time, Ken Lovell will continue to fill the role of president in order to ensure stability of the league for the common good. By-laws will be reviewed to verify procedure. During the discussion club guest emphasized the importance of clear by-law procedures and adherence. By-laws and rules will be reviewed to ensure relevance to current maturity of the league.
- FASSA Registration Issue club member signed electronic forms for players. The club incurred late registration fees associated with not having players registered by deadlines. Forms were resubmitted following proper procedure. Club representative was present to discuss the situation and took responsibility for failure to follow procedures. League administrator will send a follow-up email to the club outlining procedures, penalties, and future impacts. During discussion the idea of providing league forms in multiple languages was also discussed with no resolution.
- New FIFA rule implementation FIFA rule changes will not be recognized until after January 1, 2020 and will be implemented in the spring season.

Section A, Item 4, Paragraph C, Item V: Clubs must have a Club Representative that lives within the GVSA geographical boundaries, as defined in the Bylaws, who can make official representation on behalf of the Club.
